## SkinMed Chlorhexidine Shampoo 4%

**Shampoo for dogs, cats and horses, enriched with an ingredient that counteracts undesirable microorganisms. Packing 236 ml, 1 litre.**

### **Characteristics:**

SkinMed Chlorhexidine Shampoo is a concentrated shampoo for external coat and skin care of dogs, cats and horses, enriched with an ingredient that helps reduce the burden of unwanted microorganisms.

SkinMed Chlorhexidine Shampoo is designed to support treatment for skin and coat problems in dogs, cats and horses. In addition to its cleansing property, the product also has a deodorizing effect and restores the shine to the coat of treated animals.

### **Ingredients:**

Chlorhexidine diacetate 40 mg/g, Sodium Lauryl Ether Sulfate, Cocamidopropyl Betine, Coco-glucoside, PEG-12 Dimethicone, PEG-7 Glyceryl Cocoate, Green Tea perfume, Sodium Chloride, Polyquarternium-10, Brilliant Blue FCF dye, Citric Acid, Euxyl PE 9010, Demineralised water.

### **Dosage and method of use:**

SkinMed Chlorhexidine Shampoo is applied to the wet coat of the animal in sufficient quantity to produce sufficient foam.

The animal is thoroughly wetted with warm water. Enough shampoo is applied to create foam and more water is added if necessary. The product is massaged into the coat and skin for 2 to 5 minutes. The coat and skin are then rinsed thoroughly with clean water. If necessary, a second application of shampoo may be made. Finally, the coat is thoroughly dried. The procedure can be repeated as needed and depending on the condition of the skin and coat in 1 - 7 days. Once the condition of the skin and coat has improved, the bathing intervals can be extended.

### **Contraindications:**

The product must not be used in horses whose meat is intended for human consumption.

**Target animal species:**

Dog, cat, horse.

**Caution:**

The eyes of the animal must be protected to avoid contact with the product. Shake before use. All waste must be disposed of according to local regulations. The product is not a substitute for veterinary care and medicines recommended by a veterinarian.

**Shelf life:**

24 months

**Storage:**

Store the product at 15° C to 25° C, keep away from children.  
Do not allow the product to freeze.
